SUB : INSTRUCTIONS FOR SHIPS CALLING JEDDAH PORT FOR BUNKER ONLY

RE : M/V " " BUNKER SUPPLY AT JEDDAH ON

1. MASTER TO PASS 72 HOURS / 48 HOURS / 24 HOURS ETA NOTICES TO SUPPLIER.
2. VESSEL SHOULD CONTACT JEDDAH PORT CONTROL FROM THE MAXIMUM VHF RANGE ON CHANNEL 16 AND GET THEIR PERMISSION TO PROCEED TO SAUDI ARABIAN TERRITORIAL WATERS.
3. AFTER SAID PERMISSION IS GRANTED FROM PORT CONTROL, MASTER SHOULD PROCEED TO JEDDAH OUTER ANCHORAGE ("E") AREA AND DROP THE ANCHOR AND PASS ANCHORING TIME, POSITION, NAME OF AGENT (AL KHOMASIA) AND OTHER VESSEL'S PARTICULARS TO PORT CONTROL.
4. MASTER SHOULD CALL ANY OF BAKRI'S BUNKERING TANKERS (M/T SHAMMS OR M/T AL JIBAL) ON CHANNEL 16 AND PASS TO THEM ARRIVAL TIME AND POSITION AND COORDINATE WITH THE ASSIGNED TANKER THE PLAN FOR THE SAID SUPPLY.
5. THE SHIP WILL BE CLEARED SOONEST POSSIBLE AND PERMISSION FOR BUNKERING TANKER TO MOOR ALONGSIDE WILL BE GRANTED.

PLEASE PASS ABOVE INFORMATION TO MASTER / OWNERS FOR THEIR COMPLIANCE.
